The Members, hereinafter referred to as the Parties,

Whereas the Parties wish to establish mutually beneficial relationship.

Whereas the Parties in accordance with the present Memorandum of Understanding will encourage joint and co-operative initiatives,

The Parties hereby agree on following:



## **ARTICLE 1 SUBJECT AND SCOPE ON THE COOPERATION**

1.1. The subject of the present Memorandum of Understanding is the future cooperation between the Parties in the field of the heritage preservation and the support of solidarity and volunteering actions in that field.

## **ARTICLE 2 MODALITIES OF COOPERATION**

2.1. The Parties will build up their existing cooperation towards fostering volunteering and solidarity actions in heritage preservation, by using the tools and mechanisms they have developed in the scope of the Solidarity for Heritage Project implementation.

2.2. The Parties will exchange information on solidarity and volunteering activities under their auspices on a regular bases.

2.3. The Parties will promote, discuss and support activities related to the identified field of cooperation.

2.4. The Parties will communicate and will exchange good practices in the field of heritage preservation and volunteering on a regular bases.

2.5. The Parties will undertake joint projects of mutual interest.

## **ARTICLE 3 AMENDMENTS**

3.1. The present Memorandum of Understanding may at any time be amended in written form by mutual consent.

## **ARTICLE 4 ENTRY INTO FORCE AND DURATION**

4.1. The present Memorandum of Understanding will enter into force from the date of its signature by the representatives of each Party.

4.2. The present Memorandum of Understanding is concluded for a period of 2 (two) years and it will be automatically extended for new subsequent periods of 2 (two) years until one of the Parties will give to the other Party a written notification about the intention to terminate this Memorandum.



## ARTICLE 5 TERMINATION

5.1. Any of the six Parties may terminate at any time the cooperation under the present Memorandum providing the other Parties with a written notice for that effect at least 1 (one) month before the intended date of termination.
